## ANTI-SEIZE LUBRICANT MUST BE USED ON ALL STAINLESS STEEL FASTENERS TO PREVENT THREAD DAMAGE AND GALLING .

- 1. Remove contents from box, verify if all parts listed are present and undamaged. Carefully read and understand all instructions before attempting installation.
- 2. Locate factory welded studs on the rocker panel, See Figure 1.
- 3. Thread M8 square plastic poly retainer onto factory studs for driver side. Repeat for passenger side, see Figure 2. (Note: The plastic poly retainers are necessary to prevent reaction between supplied steel equipment and aluminum rocker panel.)
- 4. Loosely install the universal support brackets to all mounting brackets with supplied M8 carriage square neck bolt and M8 hardware, see Figure 3. (Note: See Figure 6 and 7 for placement of mounting brackets.)
- 5. Loosely install driver side mounting brackets to rocker panel with supplied M8 hardware. Repeat for passenger side, see Figure 4.
- 6. Loosely install the Pro Traxx step bar assembly to the previously installed mounting brackets with supplied M10 hardware. (Note: Driver side step tube will be packaged in a clear poly tube and passenger side will be packaged in a red poly tube, the Westin logo should face outward when installed.)
- 7. Align and adjust as necessary then torque: M8 hardware to 15-18 ft-lbs., and M10 hardware to 30-35 ft-lbs.





### LIMITED LIFETIME WARRANTY

### All Brute and HDX Tool Boxes

Westin Automotive Products warrants Brute Tool Box and HDX Truck Boxes to be free of original defects in material and workmanship to the original purchaser of the product, with proof of purchase, and is limited to the original vehicle installation. Westin warrants for 12-months from date of original purchase black powder coated finish Brute or HDX Tool Boxes. This warranty does not cover damage resulting from wear and tear of daily use, accident, misuse, neglect, improper installation, fire, vandalism or any form of abuse. This warranty is void if product is aftered in any way.

Westin will repair or replace, at its sole discretion, product covered by this warranty. If, at our discretion a product requires repair or return, the customer (end consumer) will be responsible for the cost of shipping to and from the manufacturer as needed. Standard shipping for claims is ground to and from manufacturer. Any expedited shipping fees will be incurred at the discretion of the consumer. ### FINISH PROTECTION

Westin products have a high quality finish that must be cared for like any other exposed finish on the vehicle. Protect the finish with a non-abrasive automotive wax, (e.g. Pure Carnauba) on a regular basis. The use of any soap, polish or wax that contains an abrasive is detrimental, as the compounds scratch the finish and open it to corrosion.

### DISCLAIMER FOR WINCHES

Westin warrants each Winch against factory defects in material and workmanship to the original purchaser for the period of one year. The owner will be responsible for removing the winch and returning it with freight prepaid. Westin will repair or replace at it's discretion the defective product or part. The purchaser must send a copy of the original receipt to qualify for any warranty consideration. Exclusions from this warranty are the finish and conditions determined to have been caused by abuse or abnormal use. This warranty shall not apply to any electric winch improperly operated or improperly installed. There are no warranties, expressed or implied, which extend beyond the original purchaser.
